**Meet Management  
and Organization:**

The 2011 South Central Short Course Zone Championships will be hosted and managed by the North East Independent School District. The Alamo Area Aquatic Association (AAAA), the North East Aquatic Team (NEAT) and the San Antonio Metropolitan Wing of the South Texas Swimming, Inc. will also support this meet with volunteers, technical assistance, and officials. The North East Independent School District will be responsible for the administrative operation of the meet, including entries, seeding, heat sheets, results, and hospitality. AAAA and NEAT will be responsible for the on-deck operation of the meet including timing system, console, scoreboard and timers. The AAAA Web Site ([www.aaaa-sa.org](http://www.aaaa-sa.org)) will also play a significant supporting role.

#### Facility

The Josh Davis Natatorium is part of the North East Independent School District's Blossom Athletic Center (North East Stadium) and is located at the corner of Jones-Maltsberger Road and Bitters Road / Starcrest Drive, just north of the San Antonio International Airport.

The Davis Natatorium was first opened to competition in February of 2001 and was designed to be both athlete and spectator "friendly". It is an indoor facility with eight 2.75-meter lanes and one-meter buffers outside lanes one and eight. The minimum depth is 2.5-meters and there is stadium type seating for nearly 1500 spectators. The facility is equipped with a state-of-the-art DAKTRONICS timing system and an eight-lane scoreboard with both heat and event numbers displayed.

Immediately next-door and connected by an enclosed link, is the Bill Walker Natatorium, which will have 16 twenty-five yard lanes available for continuous warm-ups and cool downs. A heat and event board will be in operation displaying information from the competition pool.

Parking and dressing facilities are excellent. There will be swim shop concessions operating in the deck-level lobby.

#### Meet Schedule

**Friday, April 1, 2011:** Warm-ups begin at 3:00 PM; Meet begins at 4:00 PM

**Saturday, April 2 and Sunday, April 3, 2011:** Warm ups begin at 7:30 AM; Meet begins at 8:30 AM. There will be continuous warm-up and warm-down in the adjacent Walker pool during the entire meet.

Sanctioned by South Texas Masters Swim committee for USMS, Inc: **#4311-78216-02**. Current United States Masters Swimming Rules will apply.

### Eligibility

Open to all registered U. S. Masters Swimmers, aged 18 and older as of April 1, 2011

### General

#### Entry Procedures

- Entries may be submitted by Hy-Tek Commlink File or disk
- Hard copy must accompany •Please format disks before utilizing for entries
- Commlink entries may be submitted ONLY via e-mail or hand delivered
- Hand-written entries must be hand-delivered or mailed to: David L. Johnson, Josh Davis Natatorium, 12002 Jones-Maltsberger, San Antonio, TX 78216-2917
- If mailed, entry fees must be submitted with the entry. If e-mailed, entry fees must be mailed and checks made **payable to N.E.I.S.D.**

#### E-Mail Entries:

- The Commlink File must be renamed to clearly identify the entering team, shorter is better.
- Athletes included in improperly identified Commlink Files (Cfile0X.cl2 or zfile00X.zip) will not be entered into the meet and any entry fees will not be refunded.
- Athletes WILL NOT be entered into Meet Manager if the Meet Entry Report (hard copy) is not received.
- Athletes WILL NOT be permitted to compete in the meet until satisfactory fee payment arrangements have been made with the Meet Director or her / his designee.

### Entry Fees

**Individual entry fee: \$45.00. Relays: \$8.00. There will be a \$20.00 surcharge for relay only participants. Late and/or Deck entries WILL NOT be accepted!**

### Entry Deadline

**Entries must be RECEIVED by 3:00 PM, Friday, March 25, 2011.** Late and/or Deck entries will **not** be accepted. A copy of an athlete's USMS card must be included in order for your entry to be accepted. If you desire entry confirmation, include a stamped, self-addressed envelope with your entry. **Deck entries WILL NOT be accepted!**

### Conduct of Meet

All events will be seeded by gender and entry time and swum **slowest to fastest**, with the exception of the 400 I-M, 500 Free, 1000 Free and 1650 Free which will be swum fastest to slowest. The 500, 1000, 1650-yard freestyles and the 400-yard individual medley will require a positive check-in on the following schedule: 1650 Free – 4:30 PM Friday, 400 I-M – 3:30 PM Friday, 1000 Free – 8:00 AM Saturday, 500 Free – 8:00 AM Sunday. They will be seeded by gender and swum **fastest to slowest**. The relay events will be deck entered and seeded by time. Relay events may be combined. Relay entries will be accepted up to one hour after the beginning of the competition each day. Swimmers participating only in relays must present a copy of their USMS card, pay a \$20.00 surcharge, and sign the liability release at the time of the entry.

### Entry Limit

Athletes may enter a maximum of **four (4)** individual and **two (2)** relay events per day.
